### Purpose

## Product

### Multi-Index Equity Fund

## What is this product?

### Type

The product is a UCITS - Special property in accordance with German authorization.

### Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The Company may, however, terminate its right to manage the fund by giving a minimum of six months' notice by way of an announcement in the Bundesanzeiger and additionally in the annual report or semiannual report. Multi-Index Equity Fund was launched in 2015.

### Objectives

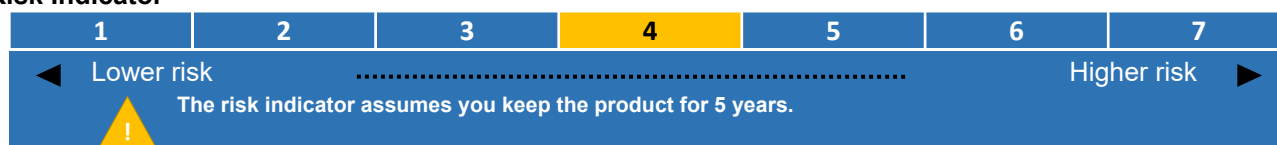
The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy of the fund is a long-term build-up of capital through investment in investment instruments from Europe, including countries outside the member states of the EU, as well as the USA. In order to achieve this, the fund can invest up to 100% in either of the two regions. This involves passive investment through the replication of widely recognized stock market indices (so-called blue chip indices) and the distribution between the two regions is adjusted from time-to-time at the discretion of the fund manager. The equity allocation may total up to 100%. Alternatively, up to 100% of the fund's assets may be invested in exchange traded funds or shares of directive-compliant Undertakings for Collective Investment in Transferable Securities (UCITS) and in assets of Undertakings for Collective Investments (UCIs). In this context, shares in domestic and foreign equity funds and near-money market funds may be acquired. In order to hedge its assets and to manage them efficiently, the fund may make use of suitable derivatives. In order to reduce currency risks, assets not denominated in euro may be hedged against the euro. The return of the product can be derived from the share price that is calculated daily plus any distribution. Returns and gains are not distributed but are reinvested in the fund. The depositary is State Street Bank International GmbH, Germany. ### Intended retail investor

The fund is aimed at private clients with a medium-term investment horizon and basic knowledge/experience and who can bear a financial loss. The fund can be used for general asset accumulation.

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 4 out of 7, which is a medium risk class. ## What happens if DWS Investment GmbH is unable to pay out?

The assets of the fund are kept separately from the own assets of the management company DWS Investment GmbH. Investors of the fund cannot suffer any financial loss as a result of this separation due to a failure of the management company. In the event of a default by the depositary State Street Bank International GmbH, Germany, investors of the fund may suffer a financial loss if their deposits are not covered by the Deposit Guarantee Fund of the Bundesverband deutscher Banken e.V.. If deposits on the fund are made with other credit institutions, investors may also suffer a financial loss, provided that such deposits are not covered by any existing deposit guarantee schemes. The protection of deposits of the fund may also be limited in the case of existing deposit guarantee schemes, as they regularly have restrictions on the coverage of deposits in accordance with their statutes.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed: In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. 10.000 EUR is invested.

## How long should I hold it and can I take money out early?

**Recommended holding period: 5 years. The product has no minimum holding period.**

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early. The asset management company may suspend the issue and redemption of shares if exceptional circumstances mean this appears necessary taking into account the investors' interests. The asset management company may use the following methods to manage liquidity risks: It may restrict redemption if the investors' redemption requests reach a previously defined threshold as of which the redemption requests can no longer be executed in the interests of all investors. By using swing pricing, it may apportion the costs arising from redemptions (e.g., transaction costs) to the investors whose orders caused the trades, thus reducing the risk of dilution for the fund's remaining investors.
