Purpose

DWS Multi Asset PIR Fund

The fund is a Luxembourg based UCITS (Undertakings for Collective Investment in Transferable Securities). The management company is **DWS Investment S.A. (the manufacturer), a member of DWS Group**. The Competent Authority Commission de Surveillance du Secteur Financier is responsible for supervising DWS Investment S.A. in relation to this Key Information Document. This PRIIP is authorised in Luxembourg. The management company DWS Investment S.A. is authorised in Luxembourg and is regulated by the Commission de Surveillance du Secteur Financier. This key information is accurate as at 16.02.2026.

What is this product?

Type

The product is a UCITS - Part 1 FCP under Luxembourg law.

Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The PFC share class of DWS Multi Asset PIR Fund was launched in 2017.

Objectives

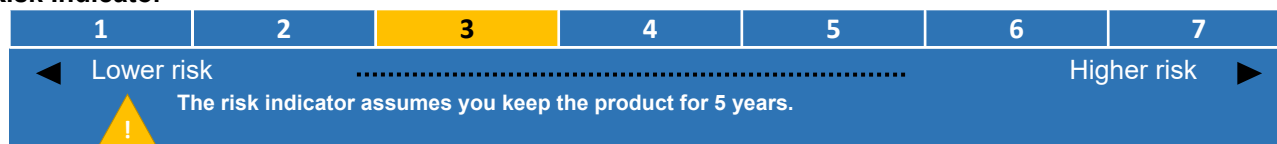
The fund is actively managed. The fund is not managed in reference to a benchmark. The fund promotes environmental and social characteristics and is subject to the disclosure requirements of a financial product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector. More ESG information is available in the sales prospectus and on the DWS website. The fund's units are included among eligible investments that shall be held in a "Piano Individuale di Risparmio a lungo termine" ("PIR") according to the Italian law 11 December 2016, n. 232 bearing "Budget Estimate of the State for financial year 2017 and according to Art. 13-bis of Law Decree October 26, 2019, n. 124 as converted into Law December 19, 2019, n. 157 ("PIR law"). In order to achieve this, the fund shall invest at least 70% of the portfolio in equities, bonds and money market instruments issued by, or entered into with companies resident in Italy, or in an EU or EEA Member State with a permanent establishment in Italy. As part of the 70% the fund can also invest in funds which are compliant with the PIR law. At least 17,5% of the fund's portfolio of these above mentioned financial instruments, shall be issued by companies which are not listed in the FTSE MIB index or in any other equivalent large-cap indices. And at least 3,5% of the fund's portfolio of these above mentioned financial instruments, shall be issued by companies which are not listed in the FTSE MIB index or in the FTSE Mid Cap index, or in any other equivalent indices of other regulated markets. Up to 30% of the portfolio may be invested globally in financial instruments such as equities, bonds, funds, certificates, money market instruments and cash. When selecting investments, environmental and social aspects and the principles of good corporate governance (ESG aspects) are taken into consideration alongside the financial performance. In this context, the selection of individual investments is the responsibility of the fund management. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. Shares may in many cases be exchanged for shares in another share class of the same fund. After 5 years commencing on the date of subscription, the relevant number of shares will be exchanged for a corresponding number of shares of the corresponding L share class of the same fund. Details can be found in the "Exchange of shares" section of the sales prospectus. The depositary is State Street Bank International GmbH, Luxembourg Branch. Intended retail investor

The fund is intended for medium term retail investors with basic knowledge/experience, who can bear losses. The fund can be used for general capital accumulation.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.

What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years. The product has no minimum holding period.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. Please refer to 'Composition of costs' table above for more information on costs when cashing in before the end of the recommended holding period.

There is no change on the risk return profile when you redeem your shares early.
