## What is this product?

### Type

The product is a UCITS - Part 1 sub-fund of a SICAV under Luxembourg law.

### Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The XC share class of DWS Invest Special Situations was launched in 2026.

### Objectives

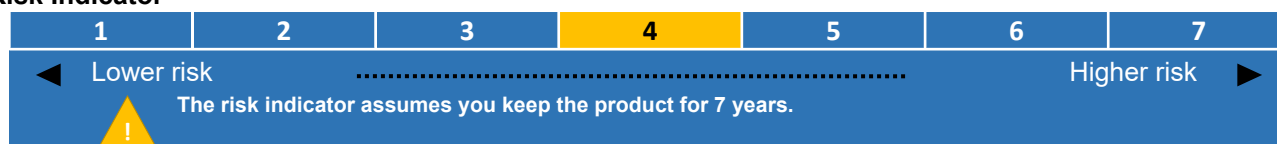
The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to achieve long term capital appreciation. In order to achieve this, the fund invests primarily in equities of worldwide of companies across all market capitalizations that, at the time of investment, are considered by the Sub-Fund Manager to be in special situation based on the Sub-Fund Manager's bottom-up analysis, research and expertise. The term "special situations" refers to a variety event-driven circumstances that may impact a company's structure, value, strategy or positioning in the market. Up to 30% of the Sub-Fund's net asset may be invested in equities of companies registered in Emerging Markets countries. A maximum of 10% of the sub-fund's assets may be invested in securities such as A-Shares, B-Shares, bonds and other securities listed and traded in Mainland China. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. This fund is a sub-fund of DWS Invest for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. Shares may in many cases be exchanged for shares in another share class of the same or another DWS Invest SICAV sub-fund. Details can be found in the "Exchange of shares" section of the sales prospectus. The depositary is State Street Bank International GmbH, Luxembourg Branch. ### Intended retail investor

The sub-fund is intended for long-term retail investors with basic knowledge/experience, who can bear losses. The sub-fund can be used for general capital accumulation.

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. ## How long should I hold it and can I take money out early?

### Recommended holding period: 7 years. The product has no minimum holding period.

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a long term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early. The asset management company may suspend the issue and redemption of shares if exceptional circumstances mean this appears necessary taking into account the investors' interests. The asset management company may use the following methods to manage liquidity risks: It may restrict redemption if the investors' redemption requests reach a previously defined threshold as of which the redemption requests can no longer be executed in the interests of all

investors. By using swing pricing, it may apportion the costs arising from redemptions (e.g., transaction costs) to the investors whose orders caused the trades, thus reducing the risk of dilution for the fund's remaining investors. Further details can be found in the Sales Prospectus.
