## What is this product?

### Type

The product is a UCITS - Part 1 sub-fund of a SICAV under Luxembourg law.

### Term

This product has a maturity until 11.06.2027. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. DWS Fixed Maturity Multi Asset 2027 II was launched in 2021.

### Objectives

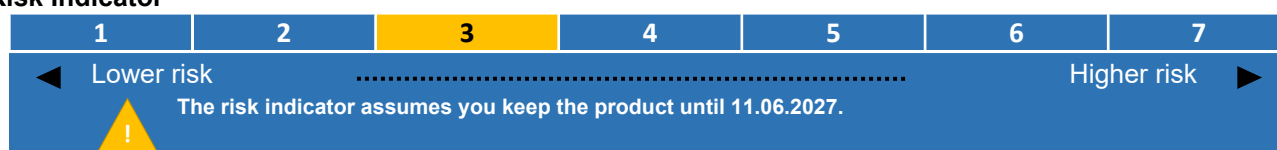
The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to pay out distributions and to achieve a positive investment performance taking into account the opportunities and risks of the international capital markets. In order to achieve this, the fund invests globally in equities, bonds, certificates, funds and cash. The fund has an investment focus on income-oriented assets such as interest-bearing securities with an attractive risk-adjusted yield and equities that are expected to deliver an above-average dividend yield or dividend growth. The investments made by the fund will be taking into consideration the maturity date of the sub-fund in 2027. Up to 100% may be invested in bonds, convertible bonds, bond funds and certificates on bonds or bond indices. Up to 75% will be invested in equities, equity funds and certificates on equity indices. Up to 20% may be invested in asset backed securities and mortgage backed securities. Up to 10% of the investment fund's assets may be invested in funds and certificates on commodities and commodity indices. The investment policy may also be implemented through the use of suitable derivatives. The selection of the individual investments is at the discretion of the fund management. The return of the product is reflected by the daily calculated net asset value per unit and the distribution amount if applicable. The fund distributes annually. This fund is a sub-fund of DWS Fixed Maturity for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. The depositary is State Street Bank International GmbH, Luxembourg Branch. ### Intended retail investor

The sub-fund is intended for medium term retail investors with basic knowledge/experience, who can bear losses. The sub-fund can be used for general capital accumulation. This fund may not be suitable for investors who want to withdraw their money from their fund before 11 June 2027.

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. **Recommended holding period: 1.36 years. The product has a fixed maturity date as of 11.06.2027.**

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a short term investment horizon. It is expected that it will be possible to achieve the investment objective of the fund within this time frame. You may request the redemption of shares generally on each valuation date. Please refer to 'Composition of costs' table above for more information on costs when cashing in before the end of the recommended holding period.

There is no change on the risk return profile when you redeem your shares early.
