## What is this product?

### Type

The product is a UCITS - Part 1 FCP under Luxembourg law.

### Term

This product is an open-ended fund without predefined maturity. You may request the redemption of shares generally on each valuation date. The company may, however, suspend the redemption if extraordinary circumstances appear to make this necessary, taking into account the interests of the investors. Further, the company may restrict the redemption. The product may be redeemed early in certain circumstances as set out in the sales prospectus. The LC share class of DWS Vermögensmandat-Defensiv was launched in 2023.

### Objectives

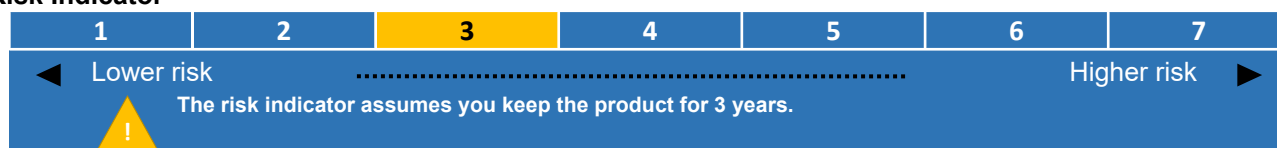
The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the investment policy is to generate a positive long term appreciation in euro. To achieve this, the fund invests its assets flexibly worldwide in equities, bonds, certificates, money market instruments and cash. The fund also may invest in derivatives for hedging and investment purposes, for example to hedge market risk. Depending on the economic cycle and the assessment by the fund management, the sub-fund will invest in different markets and instruments and, based on the market situation and the discretionary decision of the fund management, may also be 100% invested in the various asset classes listed here. A maximum of 35% of the sub-fund's assets are typically invested in equities, although market conditions may lead to a temporary departure from this range. Up to 20% may be invested in collateralized securities. The fund management does not take principal adverse impacts on sustainability factors into account separately for this sub-fund as the investment strategy does not pursue any environmental or sub-fund characteristics. The selection of the individual investments is at the discretion of the fund management. The return of the product can be derived from the share price that is calculated daily plus any distribution. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. This fund is a sub-fund of DWS Vermögensmandat for which the sales prospectus and the periodic reports are prepared as a whole. The assets and liabilities of each sub-fund are segregated by law. As a result, assets of one sub-fund are not available in the event of claims against or insolvency of another. More share classes may be available for this fund - please refer to the relevant section of the sales prospectus for further details. The shares can be exchanged for shares in the same or another sub-fund of DWS Vermögensmandat. Details can be found in the "Exchange of shares" section of the Sales Prospectus. The depositary is State Street Bank International GmbH, Luxembourg Branch. ### Intended retail investor

The sub-fund is aimed at private clients with a medium-term investment horizon and basic knowledge/experience and who can bear a financial loss. The sub-fund can be used for general asset accumulation.

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.

## What happens if DWS Investment S.A. is unable to pay out?

The assets of the fund are kept separately from those of the management company, DWS Investment S.A.. An insolvency or default of the management company should not result in the fund suffering any financial loss in relation to its assets. On the insolvency or default of the depositary State Street Bank International GmbH, Luxembourg Branch securities held by the depositary on behalf of the fund should be protected but the fund may suffer loss in relation to cash and certain other assets which are not protected. Cash deposits of the fund deposited with other credit institutions may cause investors to suffer a financial loss if such deposits are not covered by any existing deposit guarantee schemes. Investment in the fund is not covered by any investor compensation or guarantee scheme.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed: In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. 10.000 EUR is invested.

## How long should I hold it and can I take money out early?

**Recommended holding period: 3 years. The product has no minimum holding period.**

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a medium term investment horizon. It is expected that it will be possible to achieve the investment objective of

the fund within this time frame. You may request the redemption of shares generally on each valuation date. No fees or penalties will be charged by the company for any such transaction.

There is no change on the risk return profile when you redeem your shares early.
