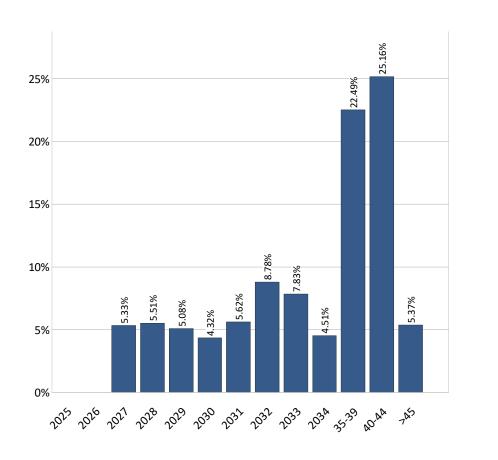

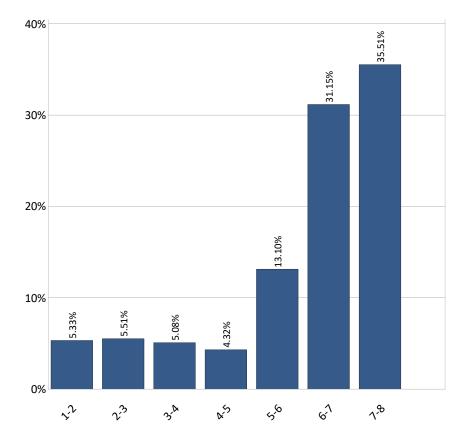

Maturity Profile





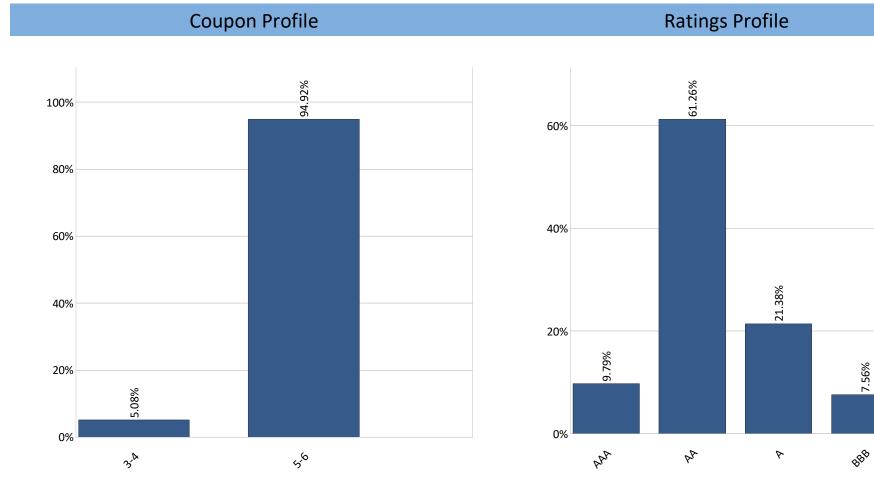

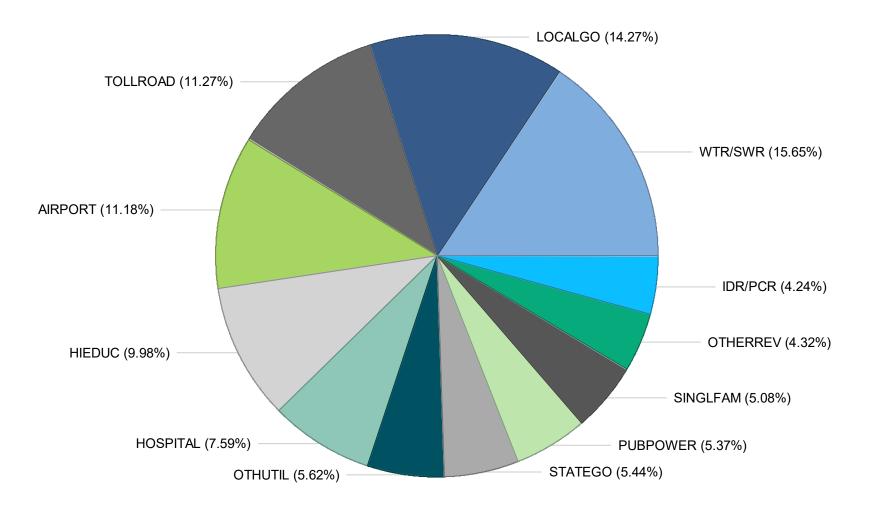
