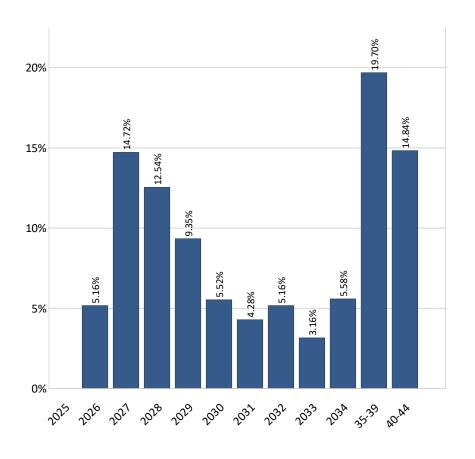

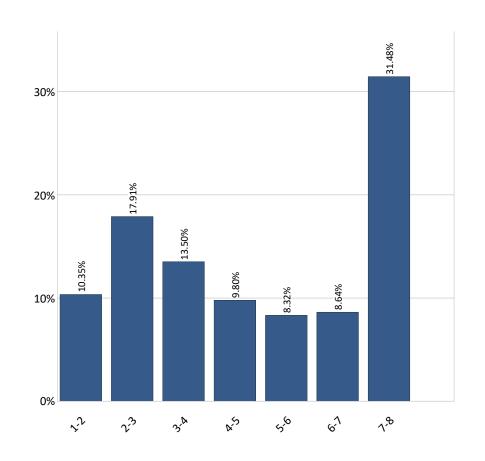
Maturity and Modified Duration

Modified Duration Profile



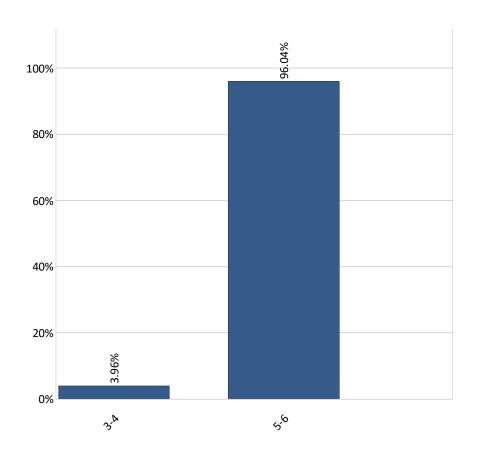

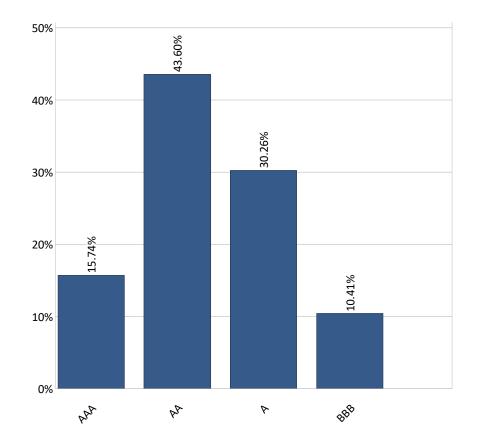

Coupon Profile



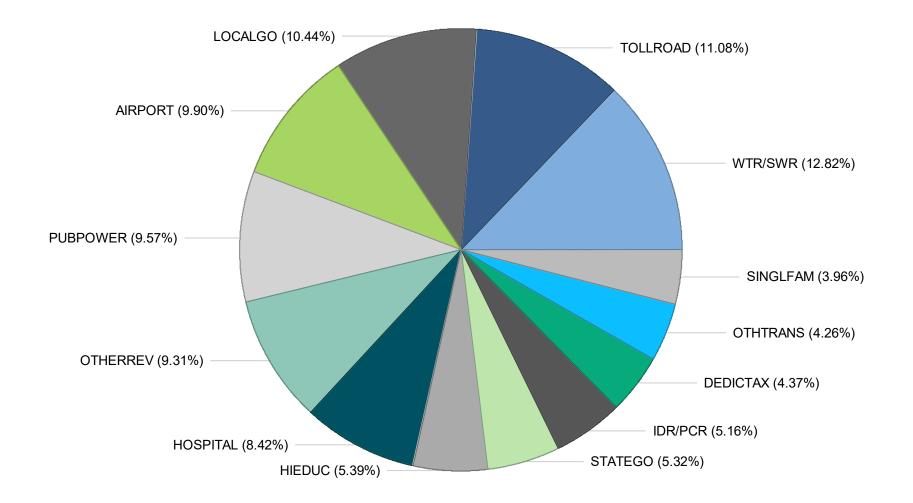
