Objectives and investment policy

The fund is actively managed. The fund is not managed in reference to a benchmark. The objective of the Sub-Fund is to preserve capital, remain liquid and seek a high level of current income. The Sub-Fund will seek to achieve its investment objective by investing in a diversified portfolio of Euro denominated short term debt and debt related instruments, including fixed- and floating-rate securities and other money market instruments. The instruments are issued by EU or non-EU sovereign governments, agencies, supranational entities, corporations and financial institutions. All investments must have ratings in one of the two highest short-term debt rating categories by a recognized statistical rating organization and/or be deemed to be of comparable high credit quality in accordance with the Investment Manager's credit quality assessment procedures. Investments must have a term to maturity of 397 days or less and the weighted

average term to maturity of investments should not exceed 60 days. The Sub-Fund has daily - same day - liquidity and is authorised as a short term Low Volatility Net Asset Value (LVNAV) money market fund under the Money Market Fund Regulation (MMFR). The Sub-Fund is also subject to the Institutional Money Market Funds Association (IMMFA) Code of Practice. The Sub-Fund has received a credit rating from an internationally recognised rating agency, and which is financed by the Sub-Fund. When selecting investments, environmental and social aspects and the principles of good corporate governance (ESG aspects) are taken into consideration alongside the financial performance. The selection of individual investments is at the discretion of the Investment Manager. The currency of the fund is EUR. Returns and gains are not distributed but are reinvested in the fund. You may request the redemption of shares generally on a daily basis.

Risk and reward profile



The calculation of the risk and reward profile is based on historical data that cannot be used as a reliable indicator for the future risk profile. This risk indicator is subject to changes; the classification of the fund may change over time and cannot be guaranteed. Even a fund that is classified in the lowest category (category 1) does not represent a completely risk-free investment. The fund is classified in category 1 because its share price generally hardly fluctuates at

all and the likelihood of both losses and gains should therefore be relatively low. The following risks could be of particular significance for the fund: The fund invests in bonds, the value of which depends on whether the issuer is able to afford its payments. The risk of a payment default may also fluctuate among issuers. Emerging market risk may be materially relevant to the Sub-Fund and is not adequately captured by the synthetic indicator above. In the event the sub-fund undertakes investments in (investment grade) emerging markets, this could result in increased risk due to the use of differing accounting standards, volatility, illiquidity, delay in settlement, custodial or political risk.

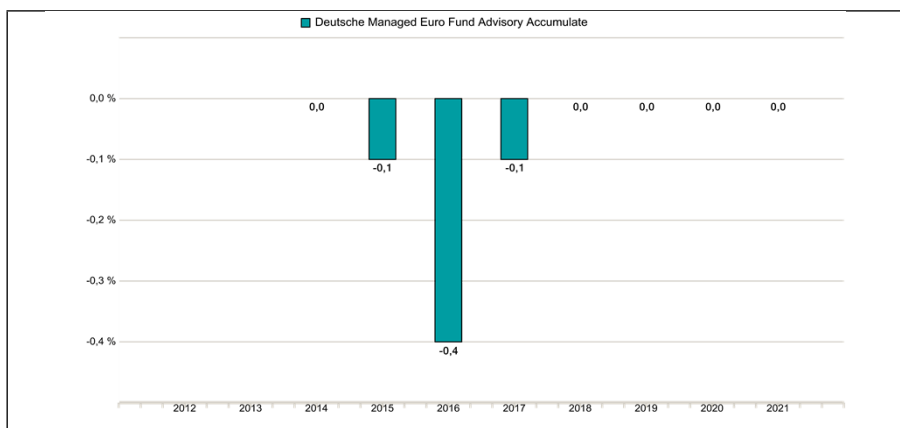
Charges
